What's Happening with eMMA Today (Release 1.1)?



The **Sourcing and Contract Modules** within eMMA include electronic workflows to automate the approval processes. The workflows are driven by data inputs from Procurement Officers and based on existing procurement processes and regulatory requirements, such as COMAR.

Upon making an apparent awardee decision, there are a series of approvals required prior to Notifying the Apparent Awardee; These approvals are captured in the Sourcing Module Workflows. Subsequent reviews, approvals and signatures are then required once the Notify Apparent Awardee step has taken place in order to have a fully executed contract or purchase order. These further approval workflows are captured within the Contracts Module.
