What's Happening with eMMA Today (Release 1.1)?

eMMA's Release 1.1, which went live in November 2020, enhanced the eMMA Sourcing Module functionality to include new Sourcing Project and Solicitation types: Secondary Level Solicitations and Emergency Procurements. This gives Procurement Officers the ability to:

- Run a secondary competition solicitation with a subset of awarded Vendors from the original Master Solicitation. These solicitations are only sent to Vendors approved on Master contracts and can be viewed by the public, but non-invited Vendors are not able to respond:
 - Purchase Order RFP: Similar to IFBs, mostly for commodities
 - o Task Order RFP: Similar to RFP solicitations, mostly for services
 - Request for Resume: unique to Consulting and Technical Services contract template categories, for human/contingent labor/contractor services
- Create an emergency procurement Sourcing Project. If a competitive bid is quickly conducted outside
 of eMMA to allow the awarded Vendor to proceed with the delivery of the product or service as soon as
 possible, a Procurement Officer can enter the details in the Sourcing Module and then create the contract
 in eMMA

What's New with Release 1.2?



A key enhancement as part of Release 1.2 is the Automated Vendor Validation Process. eMMA will automatically check and confirm a Vendor record for:

- Federal Tax ID number
- OFAC Sanctions List
- Address Check via USPS
- US Bank Routing Number (as applicable for Vendors that enroll in ACH payments)

Notifications identifying exceptions will be sent to the applicable State End Users (Vendor Coordinators and GAD). eMMA will also allow these State End Users the ability to fix the problems directly on the Vendor record or return the record to the Vendor to update and re-validate.

Release 2.0, which will focus on the requisitioning through payment processes, will kick off in Winter 2021. More information will be shared in future communications and newsletters.
